NOTICE OF PRICE VARIATION

In accordance with the [Vetting Services Terms and Conditions August 2025](#), prices will be subject to regular review by the PCC and where the PCC varies the price for the services, the customer shall be notified no less than 30 days in advance of such change taking effect.

This year's price increase of **4.2%** reflects only the direct cost pressures on the service, specifically inflation and police staff pay awards. We have taken care to limit the uplift to the minimum necessary to ensure the continued delivery of a sustainable and high-quality service.

The new pricing structure will come into effect from the 1st April 2026, this will impact all new applications received from that date.

Premium Service

For clients requiring selected employees to receive a vetting decision quickly we offer our Premium fast-tracked service. The cost for this premium service will be: -

NPPV2 (abbreviated)	£374 – SLA within 13 working days
NPPV2 (full)	£462 – SLA within 15 working days
NPPV2 + CTC	£876 – SLA within 15 working days

Time Allowed to Complete Vetting Applications

Currently, applicants have 90 days to complete their vetting application from the date it is raised by the organisation. Following valuable feedback from our customers—who highlighted that this extended timeframe did not encourage applicants to complete their forms promptly—we are introducing a positive change.

From 1 April 2026, the completion window will be reduced to 45 days. This shorter timeframe is designed to create clearer momentum in the vetting process, helping organisations progress cases more efficiently and reducing unnecessary delays.

Please note that SLA timelines will continue to begin only once a fully completed and quality-assured application form has been received.
